

FLUCTUATIONS OF THE NUMBER OF CRITICAL POINTS OF RANDOM TRIGONOMETRIC POLYNOMIALS*

Abstract. Denote by Z_ν the number of critical points of a random trigonometric polynomial of degree $\leq \nu$. We prove that as $\nu \rightarrow \infty$ the expectation of Z_ν is asymptotic to $2\nu\sqrt{\frac{3}{5}}$ while its variance is asymptotic to $\delta_\infty\nu$ where $\delta_\infty \approx 0.35$.

1. Introduction

A random trigonometric polynomial of degree $\leq \nu$ is a trigonometric polynomial of the form

$$\eta_\nu(t) = \frac{1}{\sqrt{2\pi}}a_0 + \frac{1}{\sqrt{\pi\nu}} \sum_{m=1}^{\nu} (a_m \cos mt + b_m \sin mt), \quad t \in \mathbb{R}/2\pi\mathbb{Z},$$

where a_m, b_m are independent normally distributed random variables with mean 0 and variance 1.

The number Z_ν of critical points of such a random polynomial is itself a random variable. The goal of this paper is to describe two important statistical quantities associated to this random quantity, namely its expectation, E_ν , and its variance, V_ν . We are particularly interested in the behavior of these quantities as the degree ν goes to infinity. In probabilistic parlance, η_ν is a (stationary) Gaussian process on the unit circle $\mathbb{R}/2\pi\mathbb{Z}$ and as $\nu \rightarrow \infty$ this process approaches the singular process called white noise.

The main result of this paper shows that there exist (explicit) positive constants c_1, c_2 such that

$$E_\nu \sim c_1\nu, \quad V_\nu \sim c_2\nu \quad \text{as } \nu \rightarrow \infty.$$

The above estimates imply an interesting concentration phenomenon. Suppose that we ask what are the odds that the number of critical points of a random trigonometric polynomial differs by more than 1% from the expected number of critical points. In other words we ask what is the probability of the event

$$|Z_\nu - E_\nu| \geq \frac{E_\nu}{100}.$$

The Chebyshev inequality shows

$$P(|Z_\nu - E_\nu| \geq 0.1E_\nu) \leq \frac{V_\nu}{(0.01E_\nu)^2} \sim \frac{10^4 c_2}{c_1^2 \nu} \quad \text{as } \nu \rightarrow \infty.$$

Thus, the above event is highly unlikely if the degree ν is very large. This indicates that the highly oscillatory parts of a random trigonometric polynomials have a dominant effect in the creation of critical points. This is reminiscent of the classical Poincaré phenomenon: the area of a large dimensional round sphere tends to be concentrated on a narrow tube around an Equator¹ of fixed and small codimension.

The statistics of the critical set of the above random function is identical to the statistics of the zero set of the random function

$$\xi_\nu(t) = \frac{d\eta_\nu(t)}{dt} = \frac{1}{\sqrt{\pi\nu}} \sum_{m=1}^{\nu} (-ma_m \sin mt + mb_m \cos mt).$$

Equivalently, consider the rescaled random function

$$\Phi_\nu(t) = \frac{1}{\sqrt{\pi\nu^3}} \sum_{m=1}^n \left(mc_m \cos\left(\frac{t}{\nu}\right) + md_m \sin\left(\frac{t}{\nu}\right) \right), \quad t \in [-\pi\nu, \pi\nu],$$

where c_m, d_m are independent random variables with identical standard normal distribution, and the random variable

$$Z_\nu := \text{the number of zeros of } \Phi_\nu(t) \text{ in the interval } [-\pi\nu, \pi\nu].$$

¹By Equator on a sphere centered at the origin of an Euclidean space we mean the intersection of the sphere with a vector subspace.

Note that the expectation of Z_ν is precisely the expected number of critical points of a random trigonometric polynomial in the space

$$\mathbf{T}_\nu := \text{span}\{\cos(m\theta), \sin(m\theta); m = 0, \dots, \nu\},$$

equipped with the inner product

$$(u, v) = \int_0^{2\pi} u(\theta)v(\theta)d\theta,$$

and Gaussian measure

$$d\gamma(u) = \frac{1}{(2\pi)^{\frac{\dim \mathbf{T}_\nu}{2}}} e^{-\frac{\|u\|^2}{2}} du.$$

We let $\mathbf{E}(\zeta)$, and respectively $\mathbf{var}(\zeta)$, denote the expectation, and respectively the variance, of a random variable ζ . The random function Φ_ν is a stationary Gaussian process with covariance kernel

$$R_\nu(t) = \mathbf{E}(\Phi_\nu(t)\Phi_\nu(0)) = \frac{1}{\pi\nu^3} \sum_{m=1}^{\nu} m^2 \cos\left(\frac{mt}{\nu}\right).$$

The Rice formula, [2, Eq. (10.3.1)], implies that

$$\mathbf{E}(Z_\nu) = 2\nu \left(\frac{\lambda_2(\nu)}{\lambda_0(\nu)} \right)^{\frac{1}{2}},$$

where

$$\lambda_0(\nu) = R_\nu(0) = \frac{1}{\pi\nu^3} \sum_{m=1}^{\nu} m^2 \quad \text{and} \quad \lambda_2(\nu) = -R''_\nu(0) = \frac{1}{\pi\nu^5} \sum_{m=1}^{\nu} m^4.$$

This proves that

$$(1.1) \quad \mathbf{E}(Z_\nu) \sim 2n\sqrt{\frac{3}{5}} \quad \text{as } n \rightarrow \infty.$$

The following is the main result of this paper.

Theorem 1.1. *Set*

$$\bar{\lambda}_0 := \lim_{\nu \rightarrow \infty} \lambda_0(\nu) = \frac{1}{3}, \quad \bar{\lambda}_2 := \lim_{\nu \rightarrow \infty} \lambda_2(\nu) := \frac{1}{5}.$$

Then for any $t \in \mathbb{R}$ the limit $\lim_{\nu \rightarrow \infty} R_\nu(t)$ exists, it is equal to

$$R_\infty(t) := \frac{1}{t^3} \int_0^t \tau^2 \cos \tau d\tau = \int_0^1 \lambda^2 \cos(\lambda t) d\lambda, \quad \forall t \in \mathbb{R},$$

and

$$(1.2) \quad \lim_{\nu \rightarrow \infty} \frac{1}{\nu} \mathbf{var}(Z_\nu) = \delta_\infty := \frac{2}{\pi} \int_{-\infty}^{\infty} \left(f_\infty(t) - \frac{\bar{\lambda}_2}{\bar{\lambda}_0} \right) dt + 2\sqrt{\frac{\bar{\lambda}_2}{\bar{\lambda}_0}},$$

where

$$f_\infty(t) = \frac{(\bar{\lambda}_0^2 - R_\infty^2)\bar{\lambda}_2 - \bar{\lambda}_0(R'_\infty)^2}{(\lambda_0^2 - R_\infty^2)^{\frac{3}{2}}} \left(\sqrt{1 - \rho_\infty^2} + \rho_\infty \arcsin \rho_\infty \right),$$

and

$$\rho_\infty = \frac{R''_\infty(\bar{\lambda}_0^2 - R_\infty^2) + (R'_\infty)^2 R_\infty}{(\bar{\lambda}_0^2 - R_\infty^2)\bar{\lambda}_2 - \bar{\lambda}_0(R'_\infty)^2}.$$

Moreover, the constant δ_∞ is positive.²

We should perhaps put this result in some perspective. Recently, GRANVILLE and WIGMAN [4] have investigated the behavior of the number N_ν of zeros of a random trigonometric polynomial of the form

$$P_\nu(t) = \frac{1}{\sqrt{\pi\nu}} \sum_{m=1}^{\nu} (a_m \cos mt + b_m \sin mt), \quad t \in [0, 2\pi),$$

where a_m, b_m are independent normally distributed random variables with mean 0 and variance 1. It is known that (see [3, 6])

$$\mathbf{E}(N_\nu) \sim \sqrt{\frac{2}{3}}\nu \quad \text{as } \nu \rightarrow \infty,$$

but the authors show that a much more precise result is true. More precisely, they prove that there exists $c > 0$ such that as $\nu \rightarrow \infty$ the random variable

$$\tilde{N}_\nu = \frac{1}{\sqrt{c\nu}} (N_\nu - \mathbf{E}(N_\nu))$$

converges to the standard Gaussian. Our strategy is inspired from [4] and we believe that a central limit theorem is valid in the case of the statistics of critical points as well. We plan to pursue this aspect elsewhere.

Let us observe that the space of trigonometric polynomials of degree $\leq \nu$ can be identified with the space $\mathbf{U}_L$ spanned by the eigenfunctions of the Laplacian of S^1 corresponding to eigenvalues $\leq L := \nu^2$. The estimate (1.1) can be rewritten as

$$(1.3) \quad \mathbf{E}(Z_\nu) \sim \sqrt{\frac{3}{5}} \dim \mathbf{U}_{\nu^2} \text{ as } \nu \rightarrow \infty.$$

In [5] we proved a higher dimensional generalization of this estimate. More precisely we have shown that for any $m > 0$ there exists an explicit positive constant $C_m > 0$ such that for any compact, connected, smooth m -dimensional Riemann manifold if we denote by Z_L the number of critical points of a random linear combination of eigenfunctions of the Laplacian Δ_g corresponding to eigenvalues $\leq L$, then

$$\mathbf{E}(Z_L) \sim C_m \dim \mathbf{U}_L \text{ as } L \rightarrow \infty.$$

Theorem 1.1 suggests the following higher dimensional question: does there exist a constant $c > 1$, possibly dependent on M and g , such that

$$\frac{1}{c} \dim \mathbf{U}_L < \text{var}(Z_L) < c \dim \mathbf{U}_L \text{ as } L \rightarrow \infty ?.$$

2. Proof of the main theorem

We follow a strategy inspired from [4]. The variance of Z_ν can be computed using the results in [2, §10.6]. We introduce the Gaussian field

$$\Psi(t_1, t_2) := \begin{bmatrix} \Phi_\nu(t_1) \\ \Phi_\nu(t_2) \\ \Phi'_\nu(t_1) \\ \Phi'_\nu(t_2) \end{bmatrix}.$$

Its covariance matrix depends only on $t = t_2 - t_1$. We have (compare with [4, Eq. (17)])

$$\Xi(t) = \begin{bmatrix} \lambda_0 & R_\nu(t) & 0 & R'_\nu(t) \\ R_\nu(t) & \lambda_0 & -R'_\nu(t) & 0 \\ 0 & -R'_\nu(t) & \lambda_2 & -R''_\nu(t) \\ R'_\nu(t) & 0 & -R''_\nu(t) & \lambda_2 \end{bmatrix} =: \begin{bmatrix} A & B \\ B^\dagger & C \end{bmatrix}.$$

As explained in [6], to apply [2, §10.6] we only need that $\Xi(t)$ is non-degenerate. This is established in the next result whose proof can be found in Appendix A.

Lemma 2.1. *The matrix $\Xi(t)$ is nonsingular if and only if $t \notin 2\pi\nu\mathbb{Z}$.* $\square$

For any vector

$$\mathbf{x} := \begin{bmatrix} x_1 \\ x_2 \\ x_3 \\ x_4 \end{bmatrix} \in \mathbb{R}^4$$

we set

$$p_{t_1, t_2}(\mathbf{x}) := \frac{1}{4\pi^2(\det \Xi)^{1/2}} e^{-\frac{1}{2}(\Xi^{-1}\mathbf{x}, \mathbf{x})}.$$

Then, the results in [2, §10.6] show that

$$(2.1) \quad \mathbf{E}(Z_\nu^2) - \mathbf{E}(Z_\nu) = \int_{I_\nu \times I_\nu} \left(\int_{\mathbb{R}^2} |y_1 y_2| \cdot p_{t_1, t_2}(0, 0, y_1, y_2) |dy_1 dy_2| \right) |dt_1 dt_2|.$$

As in [4] we have

$$\Xi(t)^{-1} = \begin{bmatrix} * & * \\ * & \Omega^{-1} \end{bmatrix}, \quad \Omega = C - B^\dagger A^{-1} B.$$

More explicitly,

$$\begin{aligned} \Omega &= C - B^\dagger A^{-1} B \\ &= \begin{bmatrix} \lambda_2 & -R_\nu''(t) \\ -R_\nu''(t) & \lambda_2 \end{bmatrix} \\ &\quad - \frac{1}{\lambda_0^2 - R_\nu(t)^2} \begin{bmatrix} 0 & -R_\nu'(t) \\ R_\nu'(t) & 0 \end{bmatrix} \cdot \begin{bmatrix} \lambda_0 & -R_\nu(t) \\ -R_\nu(t) & \lambda_0 \end{bmatrix} \cdot \begin{bmatrix} 0 & R_\nu'(t) \\ -R_\nu'(t) & 0 \end{bmatrix} \\ &= \begin{bmatrix} \lambda_2 & -R_\nu'' \\ -R_\nu'' & \lambda_2 \end{bmatrix} - \frac{(R_\nu')^2}{\lambda_0^2 - R_\nu^2} \begin{bmatrix} \lambda_0 & R_\nu \\ R_\nu & \lambda_0 \end{bmatrix} = \mu \begin{bmatrix} 1 & -\rho \\ -\rho & 1 \end{bmatrix}, \end{aligned}$$

where

$$\mu = \mu_\nu = \frac{(\lambda_0^2 - R_\nu^2)\lambda_2 - \lambda_0(R_\nu')^2}{\lambda_0^2 - R_\nu^2}, \quad \rho = \rho_\nu = \frac{R_\nu''(\lambda_0^2 - R_\nu^2) + (R_\nu')^2 R_\nu}{(\lambda_0^2 - R_\nu^2)\lambda_2 - \lambda_0(R_\nu')^2}.$$

We want to emphasize that in the above equalities the constants λ_0 and λ_2 do depend on ν , although we have not indicated this in our notation.

Remark 2.2. The nondegeneracy of Ξ implies that $\mu_\nu(t) \neq 0$ and $|\rho_\nu(t)| < 1$, for all $t \notin 2\pi\nu\mathbb{Z}$. $\square$

We obtain as in [4, Eq. (24)]

$$\det \Xi = \det A \cdot \det \Omega = \mu^2(\lambda_0^2 - R_\nu^2)(1 - \rho^2), \quad \Omega^{-1} = \frac{1}{\mu(1 - \rho^2)} \begin{bmatrix} 1 & \rho \\ \rho & 1 \end{bmatrix}.$$

We can now rewrite the equality (2.1) as ($t = t_2 - t_1$)

$$\begin{aligned} & \mathbf{E}(Z_\nu^2) - \mathbf{E}(Z_\nu) \\ &= \int_{I_\nu \times I_\nu} \left(\int_{\mathbb{R}^2} |y_1 y_2| e^{-\frac{y_1^2 + 2\rho y_1 y_2 + y_2^2}{2\mu(1-\rho^2)}} \frac{|dy_1 dy_2|}{4\pi^2} \right) \frac{|dt_1 dt_2|}{\mu \sqrt{(\lambda_0^2 - R_\nu^2)(1 - \rho^2)}} \\ &= \int_{I_\nu \times I_\nu} \left(\int_{\mathbb{R}^2} |y_1 y_2| e^{-\frac{y_1^2 + 2\rho y_1 y_2 + y_2^2}{2(1-\rho^2)}} \frac{|dy_1 dy_2|}{4\pi^2} \right) \frac{\mu |dt_1 dt_2|}{\sqrt{(\lambda_0^2 - R_\nu^2)(1 - \rho^2)}}. \end{aligned}$$

From [1, Eq. (A.1)] we deduce that

$$\int_{\mathbb{R}^2} |y_1 y_2| e^{-\frac{y_1^2 + 2\rho y_1 y_2 + y_2^2}{2(1-\rho^2)}} \frac{|dy_1 dy_2|}{4\pi^2} = \frac{1 - \rho^2}{\pi^2} \left(1 + \frac{\rho}{\sqrt{1 - \rho^2}} \arcsin \rho \right).$$

Hence

$$\begin{aligned} \mathbf{E}(Z_\nu^2) - \mathbf{E}(Z_\nu) &= \frac{1}{\pi^2} \int_{I_\nu \times I_\nu} \frac{\mu}{(\lambda_0^2 - R_\nu^2)^{\frac{1}{2}}} \left(\sqrt{1 - \rho^2} + \rho \arcsin \rho \right) |dt_1 dt_2| \\ (2.2) \quad &= \frac{1}{\pi^2} \int_{I_\nu \times I_\nu} \underbrace{\frac{(\lambda_0^2 - R_\nu^2)\lambda_2 - \lambda_0(R'_\nu)^2}{(\lambda_0^2 - R_\nu^2)^{\frac{3}{2}}} \left(\sqrt{1 - \rho^2} + \rho \arcsin \rho \right)}_{=: f_\nu(t)} |dt_1 dt_2|. \end{aligned}$$

The function $f_\nu(t) = f_\nu(t_2 - t_1)$ is doubly periodic with periods $2\pi\nu$, $2\pi\nu$ and we conclude that

$$(2.3) \quad \mathbf{E}([Z_\nu]_2) := \mathbf{E}(Z_\nu^2) - \mathbf{E}(Z_\nu) = \frac{2\nu}{\pi} \int_{-\pi\nu}^{\pi\nu} f_\nu(t) dt.$$

We conclude that

$$\begin{aligned} \mathbf{var}(Z_\nu) &= \mathbf{E}([Z_\nu]_2) + \mathbf{E}(Z_\nu) - (\mathbf{E}(Z_\nu))^2 = \mathbf{E}([Z_\nu]_2) - [\mathbf{E}(Z_\nu)]_2 \\ (2.4) \quad &= \frac{2\nu}{\pi} \int_{-\pi\nu}^{\pi\nu} \left(f_\nu(t) - \frac{\lambda_2}{\lambda_0} \right) dt + 2\nu \sqrt{\frac{\lambda_2}{\lambda_0}}. \end{aligned}$$

To complete the proof of Theorem 1.1 we need to investigate the integrand in (2.3). This requires a detailed understanding of the behavior of R_ν as $\nu \rightarrow \infty$. It is useful to consider more general sums of the form

$$A_{\nu,r}(t) = \frac{1}{\nu^{r+1}} \sum_{m=1}^{\nu} m^r \cos \frac{mt}{\nu}, \quad B_{\nu,r}(t) = \frac{1}{\nu^{r+1}} \sum_{m=1}^{\nu} m^r \sin \frac{mt}{\nu}, \quad r \geq 1.$$

Note that if we set $z := \cos \frac{mt}{\nu} + i \sin \frac{mt}{\nu}$. We have

$$A_{\nu,r}(t) + iB_{\nu,r}(t) = \frac{1}{\nu^{r+1}} \underbrace{\sum_{m=1}^{\nu} m^r z^m}_{=: C_{\nu,r}(t)}.$$

Observe that

$$(2.5) \quad R_\nu^{(k)}(t) = -\frac{1}{\pi \nu^{k+3}} \operatorname{Re} \left(\frac{1}{i^{k+2}} C_{\nu,k+2}(t) \right).$$

We set

$$A_{\infty,r}(t) = \frac{1}{t^{r+1}} \int_0^t \tau^r \cos \tau d\tau, \quad B_{\infty,r}(t) := \frac{1}{t^{r+1}} \int_0^t \tau^r \sin \tau d\tau.$$

Observe that $R_\nu = A_{\nu,2}$ and $R_\infty = A_{\infty,2}$. We have the following result.

Lemma 2.3.

$$(2.6) \quad |A_{\nu,r}(t) - A_{\infty,r}(t)| + |B_{\nu,r}(t) - B_{\infty,r}(t)| = O \left(\frac{\max(1, t)}{\nu} \right), \quad \forall t \geq 0,$$

where, above and in the sequel, the constant implied by the O -symbol is independent of t and ν . In particular

$$(2.7) \quad \lim_{\nu \rightarrow \infty} \frac{1}{\nu^{r+1}} C_{\nu,r}(t) = C_r(t) := \frac{1}{t^{r+1}} \int_0^t \tau^r e^{i\tau} d\tau, \quad \forall t \geq 0.$$

Proof. We have

$$A_\nu(t) = \frac{1}{\nu^{r+1}} \sum_{m=1}^{\nu} m^r \cos \left(\frac{mt}{\nu} \right) = \frac{1}{t^{r+1}} \underbrace{\sum_{m=1}^{\nu} \left\{ \left(\frac{mt}{\nu} \right)^r \cos \left(\frac{mt}{\nu} \right) \right\}}_{=: S_\nu(t)} \cdot \left(\frac{t}{\nu} \right).$$

The term $S_\nu(t)$ is a Riemann sum corresponding to the integral

$$\int_0^t f(\tau) d\tau, \quad f(\tau) := \tau^r \cos \tau,$$

and the subdivision

$$0 < \frac{t}{\nu} < \dots < \frac{(\nu-1)t}{\nu} < t.$$

of the interval $[0, t]$. A simple application of the mean value theorem implies that there exist points

$$\theta_m \in \left[\frac{(m-1)t}{\nu}, \frac{mt}{\nu} \right]$$

such that

$$\int_0^t f(\tau) d\tau = \sum_{m=1}^{\nu} f(\theta_m) \frac{t}{m}.$$

We deduce that

$$\int_0^t f(\tau) d\tau - S_\nu(t) = \frac{t}{\nu} \sum_{m=1}^{\nu} \left(f(\theta_m) - f\left(\frac{mt}{\nu}\right) \right).$$

Now set

$$M(t) := \sup_{0 \leq \tau \leq t} |f'(\tau)|.$$

Observe that

$$M(t) = \begin{cases} O(t^{r-1}), & 0 \leq t \leq 1 \\ O(t^r), & t > 1. \end{cases}$$

We deduce

$$\left| S_\nu(t) - \int_0^t f(\tau) d\tau \right| \leq M(t) \cdot \frac{t^2}{\nu}.$$

This, proves the A -part of (2.6). The B -part is completely similar. $\square$

We need to refine the estimates (2.6). Recall that $[m]_r := m(m-1) \cdots (m-r+1)$, $r \geq 1$. We will express $C_{\nu,r}(t)$ in terms of the sums

$$\begin{aligned} D_{\nu,r}(t) &:= \sum_{m=1}^{\nu} [m]_r z^m = z^r \frac{d^r}{dz^r} \left(\sum_{k=1}^{\nu} z^k \right) = z^r \frac{d^r}{dz^r} \left(\frac{z - z^{\nu+1}}{1 - z} \right) \\ &= z^r \frac{d^r}{dz^r} \left(\frac{1 - z^{\nu+1}}{1 - z} \right). \end{aligned}$$

Using the classical formula, [7, §1.4, Eq. (24d)],

$$m^r = \sum_{k=1}^r S(r, k)[m]_k,$$

where $S(r, k)$ are the Stirling numbers of the second kind, we deduce,

$$(2.8) \quad C_{\nu, r}(\zeta) = \sum_{k=1}^r S(r, k) D_{\nu, k}(\zeta) = \sum_{k=1}^r S(r, k) z^r \frac{d^k}{dz^k} \left(\frac{1 - z^{\nu+1}}{1 - z} \right).$$

Lemma 2.4. Set $\theta := \frac{t}{2\nu}$, and $f(\theta) = \frac{\sin \theta}{\theta}$. Then

$$(2.9) \quad \frac{t^{r+1}}{\nu^{r+1}} D_{\nu, r}(t) = i^r r! \left(\frac{2 \sin \left(\frac{(\nu+1)t}{2\nu} \right)}{f(\theta)^{r+1}} \cdot e^{\frac{i(\nu+r)t}{2\nu}} - e^{it} \sum_{j=1}^r i^{1-j} \binom{\nu+1}{j} t^j \cdot \left(\frac{e^{i\theta}}{f(\theta)} \right)^{r+1-j} \right).$$

Proof. We have

$$\begin{aligned} D_{\nu, r}(t) &= z^r \sum_{j=0}^r \binom{r}{j} \frac{d^j}{dz^j} (1 - z^{\nu+1}) \frac{d^{r-j}}{dz^{r-j}} (1 - z)^{-1} \\ &= r! \frac{z^r (1 - z^{\nu+1})}{(1 - z)^{r+1}} - \sum_{j=1}^r \binom{r}{j} [\nu+1]_j (r-j)! \frac{z^{\nu+1+r-j}}{(1 - z)^{1+r-j}} \\ &= r! \frac{z^r (1 - z^{\nu+1})}{(1 - z)^{r+1}} - z^\nu r! \sum_{j=1}^r \binom{\nu+1}{j} \left(\frac{z}{1 - z} \right)^{r+1-j}. \end{aligned}$$

Using the identity

$$1 - e^{i\alpha} = \frac{2}{i} \sin \left(\frac{\alpha}{2} \right) e^{\frac{i\alpha}{2}}$$

we deduce

$$\frac{z}{1 - z} = \frac{ie^{\frac{it}{2\nu}}}{2 \sin \left(\frac{t}{2\nu} \right)},$$

and

$$D_{\nu, r}(t) = i^r \frac{r! \sin \left(\frac{(\nu+1)t}{2\nu} \right) e^{\frac{i(\nu+1+2r)t}{2\nu}}}{\sin^{r+1} \left(\frac{t}{2\nu} \right) e^{\frac{(r+1)it}{2\nu}}} - e^{it} r! \sum_{j=1}^r i^{r+1-j} \binom{\nu+1}{j} \frac{e^{i(r+1-j)\theta}}{(2 \sin \theta)^{r+1-j}}$$

$$= i^r r! \left(\frac{2 \sin \left(\frac{(\nu+1)t}{2\nu} \right)}{(2 \sin \theta)^{r+1}} \cdot e^{\frac{i(\nu+r)t}{2\nu}} - e^{it} \sum_{j=1}^r i^{1-j} \binom{\nu+1}{j} \left(\frac{e^{i\theta}}{2 \sin \theta} \right)^{1+r-j} \right).$$

Multiplying both sides of the above equality by $\left(\frac{t}{\nu}\right)^{r+1}$ we get (2.9). $\square$

Lemma 2.4 coupled with the fact that the function $f(\theta)$ is bounded on $[0, \frac{\pi}{2}]$ yield the following estimate.

$$(2.10) \quad \frac{t^{r+1}}{\nu^{r+1}} D_{\nu,r}(t) = O(1), \quad \forall \nu, \quad 0 \leq t \leq \pi\nu.$$

Using (2.10) and the identity $S(r, 1) = 1$ in (2.8) we deduce that there exists $K = K_r > 0$ such that for any $\nu > 0$ and any $t \in [0, \pi\nu]$ we have

$$\left| \frac{t^{r+1}}{\nu^{r+1}} \left(C_{\nu,r}(t) - D_{\nu,r}(t) \right) \right| \leq K_r \sum_{j=0}^{r-1} \left| \frac{t^{r+1}}{\nu^{r+1}} D_{\nu,j}(t) \right| \leq K_r \sum_{j=0}^{r-1} \left(\frac{t}{\nu} \right)^{r-j} \leq K_r \frac{t}{\nu},$$

so that

$$(2.11) \quad \left| \frac{1}{\nu^{r+1}} \left(C_{\nu,r}(t) - D_{\nu,r}(t) \right) \right| \leq K_r \frac{1}{\nu t^r}.$$

Using Lemma 2.4 we deduce

$$(2.12) \quad \lim_{\nu \rightarrow \infty} \frac{t^{r+1}}{\nu^{r+1}} \mathbf{Re} D_{\nu,r}(t) = I_r(t) := i^r r! \left(2 \sin \left(\frac{t}{2} \right) \cdot e^{\frac{it}{2}} - e^{it} \sum_{j=1}^r i^{1-j} \frac{t^j}{j!} \right).$$

uniformly for t on compacts. The estimate (2.11) implies that

$$\lim_{\nu \rightarrow \infty} \frac{t^{r+1}}{\nu^{r+1}} \mathbf{Re} D_{\nu,r}(t) = I_r(t).$$

We have the following crucial estimate whose proof can be found in Appendix A.

Lemma 2.5. *For every $r \geq 0$ there exists $C_r > 0$ such that for any $\nu > 0$ we have*

$$\left| \frac{1}{\nu^{r+1}} D_{\nu,r}(t) - \frac{1}{t^{r+1}} I_r(t) \right| \leq \frac{C_r}{\nu} \frac{t^{r+1} - 1}{t^r(t-1)}, \quad \forall 0 < t \leq \pi\nu.$$

$\square$

Using Lemma 2.5 in (2.11) we deduce

$$(2.13a) \quad \left| \frac{1}{\nu^{r+1}} C_{\nu,r}(t) - \frac{1}{t^{r+1}} I_r(t) \right| \leq \frac{C_r}{\nu} \frac{t^{r+1} - 1}{t^r(t-1)}, \quad \forall 0 < t \leq \pi\nu.$$

$$(2.13b) \quad I_r(t) = t^{r+1} C_r(t) = \int_0^t \tau^r e^{i\tau} d\tau.$$

Using (2.6) and (2.13a) we deduce that for any nonnegative integer r there exists a positive constant $K = K_r > 0$ such that

$$(2.14) \quad |C_{\nu,r}(t) - C_r(t)| \leq \frac{K_r}{\nu} \frac{t^{r+1} - 1}{t^r(t-1)}.$$

Coupling the above estimates with (2.6) we deduce

$$(2.15) \quad C_{\nu,r}(t) = C_r(t) + O\left(\frac{1}{\nu}\right), \quad \forall 0 \leq t \leq \nu,$$

where the constant implied by the symbol O depends on k , but it is independent of ν . The last equality coupled with (2.5) implies that

$$(2.16) \quad R_\nu^{(k)}(t) = R_\infty^{(k)}(t) + O\left(\frac{1}{\nu}\right), \quad \forall 0 \leq t \leq \nu.$$

We deduce that, for any $t > 0$ we have

$$\lim_{\nu \rightarrow \infty} f_\nu(t) = f_\infty(t),$$

where f_ν is the function defined in (2.2), while

$$(2.17) \quad f_\infty(t) = \frac{(\bar{\lambda}_0^2 - R_\infty^2)\bar{\lambda}_2 - \bar{\lambda}_0(R'_\infty)^2}{(\bar{\lambda}_0^2 - R_\infty^2)^{\frac{3}{2}}} \left(\sqrt{1 - \rho_\infty^2} + \rho_\infty \arcsin \rho_\infty \right),$$

where

$$\begin{aligned} \bar{\lambda}_0 &= \lambda_0(\infty) = \lim_{\nu \rightarrow \infty} \lambda_0(\nu) = \frac{1}{3}, \quad \bar{\lambda}_2 = \lim_{\nu \rightarrow \infty} \lambda_2(\nu) = \frac{1}{5}, \\ \rho_\infty(t) &= \lim_{\nu \rightarrow \infty} \rho_\nu(t) = \frac{R_\infty''(\bar{\lambda}_0^2 - R_\infty^2) + (R'_\infty)^2 R_\infty}{(\bar{\lambda}_0^2 - R_\infty^2)\bar{\lambda}_2 - \bar{\lambda}_0(R'_\infty)^2}. \end{aligned}$$

We have the following result whose proof can be found in Appendix A.

Lemma 2.6.

$$(2.18a) \quad |R_\infty(t)| < R_\infty(0), |R'_\infty(t)| < |R'_\infty(0)|, \quad \forall t > 0,$$

$$(2.18b) \quad R_\infty(t), \quad R'_\infty(t), \quad R''_\infty(t) = O\left(\frac{1}{t}\right) \quad \text{as } t \rightarrow \infty.$$

$$(2.18c) \quad (\bar{\lambda}_0^2 - R_\infty^2)\bar{\lambda}_2 - \bar{\lambda}_0(R'_\infty)^2 > 0, \quad \forall t > 0.$$

$$(2.18d) \quad \begin{aligned} R_\infty(t) &= \frac{1}{3} - \frac{1}{10}t^2 + \frac{1}{168}t^4 + O(t^6), \\ R'_\infty(t) &= -\frac{1}{5}t + \frac{1}{42}t^3 + O(t^5), \quad \text{as } t \rightarrow 0. \end{aligned}$$

□

We set

$$\delta(t) := \max(t, 1), \quad t \geq 0.$$

We find it convenient to introduce new functions

$$G_\nu(t) := \frac{1}{R_\nu(0)}R_\nu(t) = \frac{1}{\lambda_0(\nu)}R_\nu(t), \quad H_\nu(t) = \frac{1}{R'_\nu(0)}R'_\nu(t) = -\frac{1}{\lambda_2(\nu)}R''_\nu(t).$$

Using these notations we can rewrite (2.18c) as

$$(2.19) \quad \underbrace{(1 - G_\infty^2) - \frac{\bar{\lambda}_0}{\bar{\lambda}_2}(G'_\infty)^2}_{=: \eta(t)} > 0, \quad \forall t > 0.$$

The equalities (2.18d) imply that

$$(2.20) \quad \eta(t) = \frac{3}{4375}t^4 + O(t^6), \quad \forall |t| \ll 1.$$

Then

$$f_\nu(t) = \frac{\lambda_2(\nu)}{\lambda_0(\nu)} \times \mathcal{C}_\nu(t) \times \left(\sqrt{1 - \rho_\nu^2} + \rho_\nu \arcsin \rho_\nu \right),$$

where

$$\mathcal{C}_\nu(t) := \frac{(1 - G_\nu(t)^2) - \frac{\lambda_0(\nu)}{\lambda_2(\nu)}(G'_\nu(t))^2}{(1 - G_\nu(t)^2)^{3/2}},$$

and

$$\rho_\nu = \frac{R''_\nu(\lambda_0(\nu)^2 - R_\nu^2) + (R'_\nu)^2 R_\nu}{(\lambda_0^2(\nu) - R_\nu^2)\lambda_2(\nu) - \lambda_0(R'_\nu)^2} = \frac{-H_\nu(1 - G_\nu^2) + \frac{\lambda_0(\nu)}{\lambda_2(\nu)}(G'_\nu)^2 G_\nu}{(1 - G_\nu^2) - \frac{\lambda_0(\nu)}{\lambda_2(\nu)}(G'_\nu)^2}.$$

Lemma 2.7. *Let $\kappa \in (0, 1)$. Then*

$$\mathcal{C}_\nu(t) = O(t), \quad \forall 0 \leq t \leq \nu^{-\kappa},$$

where the constant implied by O -symbol is independent of ν and $t \in [0, \nu^{-\kappa})$, but it could depend on κ .

Proof. Observe that for $t \in [0, \nu^{-\kappa}]$ we have

$$G_\nu(t) = 1 - \frac{\lambda_2(\nu)}{2\lambda_0(\nu)}t^2 + O(t^4), \quad G'_\nu(t) = -\frac{\lambda_2(\nu)}{\lambda_0(\nu)}t + O(t^3)$$

so that

$$(1 - G_\nu(t)^2)^{-3/2} = \left(\frac{\lambda_2(\nu)}{\lambda_0(\nu)}t\right)^{-3} \times (1 + O(t)),$$

and

$$(1 - G_\nu(t)^2) - \frac{\lambda_0(\nu)}{\lambda_2(\nu)}(G'_\nu)^2 = O(t^4)$$

so that $\mathcal{C}_\nu(t) = O(t)$. □

Lemma 2.8. *Let $\kappa \in (0, 1)$,*

$$\eta(t) := (1 - G_\nu^2) - \frac{\bar{\lambda}_0}{\lambda_2}(G'_\nu)^2 \quad \text{and} \quad \gamma(t) = 1 - G_\infty(t)^2.$$

Then as $\nu \rightarrow \infty$ and $t > \nu^{-\kappa}$ we have

$$(2.21) \quad \mathcal{C}_\nu = \mathcal{C}_\infty \times \left(1 + O\left(\frac{(G'_\infty)^2}{\nu\eta(t)} + \frac{1}{\nu\gamma(t)\delta(t)} + \frac{1}{\nu\delta(t)\eta(t)} + \frac{1}{\nu^2\eta(t)}\right)\right),$$

and

$$(2.22) \quad \mathcal{C}_\nu(t) = \mathcal{C}_\infty(t) + O\left(\frac{(G'_\infty)^2}{\nu\gamma(t)^{3/2}} + \frac{\eta(t)}{\nu\delta(t)\gamma(t)^{3/2}} + \frac{1}{\nu\delta(t)\gamma(t)^{3/2}} + \frac{1}{\nu^2\gamma(t)^{3/2}}\right),$$

uniformly for $t > \nu^{-\kappa}$.

Proof. Observe that

$$(2.23) \quad G_\nu^2 = \left(G_\infty + O\left(\frac{1}{\nu}\right)\right)^2 \stackrel{(2.18b)}{=} G_\infty^2 + O\left(\frac{1}{\nu\delta(t)}\right),$$

so that

$$1 - G_\infty(t)^2(t) = (1 - G_\infty(t)^2) \left(1 + O \left(\frac{1}{\nu \delta(t) \gamma(t)} \right) \right).$$

For $t > \nu^{-\kappa}$ we have

$$\frac{1}{\nu \delta(t) \gamma(t)} = O \left(\frac{1}{\nu^{1-\kappa}} \right) = o(1) \text{ uniformly in } t > \nu^{-\kappa} \text{ as } \nu \rightarrow \infty.$$

Hence

$$(2.24) \quad \begin{aligned} (1 - G_\nu^2)^{-3/2} &= (1 - G_\infty^2)^{-3/2} \left(1 + O \left(\frac{1}{\nu \delta(t) \gamma(t)} \right) \right), \\ \gamma(t) &:= 1 - G_\infty^2(t). \end{aligned}$$

Next observe that

$$(2.25) \quad \begin{aligned} \lambda_0(\nu) &= \frac{B_3(\nu+1)}{3\nu^3} = \frac{1}{3} + \nu^{-1} + O(\nu^{-2}), \\ \lambda_2(\nu) &= \frac{B_5(\nu+1)}{5\nu^5} = \frac{1}{5} + \nu^{-1} + O(\nu^{-2}) \end{aligned}$$

and

$$\frac{\lambda_0(\nu)}{\lambda_2(\nu)} = \frac{\frac{1}{3} + \nu^{-1} + O(\nu^{-2})}{\frac{1}{5} + \nu^{-1} + O(\nu^{-2})} = \frac{5}{3} - \frac{10}{3}\nu^{-1} + O(\nu^{-2}).$$

Using (2.23) and the above estimate we deduce

$$(2.26) \quad \begin{aligned} &(1 - G_\nu(t)^2) - \frac{\lambda_0(\nu)}{\lambda_2(\nu)} (G'_\nu)^2 \\ &= \underbrace{(1 - G_\infty^2) - \frac{\bar{\lambda}_0}{\bar{\lambda}_2} (G'_\infty)^2}_{\eta(t)} + \frac{10}{3\nu} (G'_\infty)^2 + O \left(\frac{1}{\nu \delta(t)} \right) + O \left(\frac{1}{\nu^2} \right) \\ &= \left((1 - G_\infty^2) - \frac{\bar{\lambda}_0}{\bar{\lambda}_2} (G'_\infty)^2 \right) \cdot \left(1 + O \left(\frac{(G'_\infty)^2}{\nu \eta(t)} + \frac{1}{\nu \delta(t) \eta(t)} + \frac{1}{\nu^2 \eta(t)} \right) \right). \end{aligned}$$

Using (2.24) we deduce (2.21). The estimate (2.22) follows from (2.21) by invoking the definitions of $\gamma(t)$ and $\eta(t)$. $\square$

Lemma 2.9. *Let $\kappa \in (0, \frac{1}{4})$. Then*

$$(2.27) \quad \rho_\nu = \rho_\infty + O\left(\frac{1}{\nu\eta(t)} + \frac{(G'_\infty)^2}{\nu\eta(t)\delta(t)} + \frac{1}{\nu\delta(t)^2} + \frac{1}{\nu\delta(t)^2\eta(t)} + \frac{1}{\nu^2\eta(t)\delta(t)}\right),$$

$$\forall t > \nu^{-\kappa},$$

where the constant implied by O -symbol is independent of ν and $t > \nu^{-\kappa}$, but it could depend on κ .

Proof. The estimates (2.18b), (2.18d) and (2.20) imply that for $t > \nu^{-\kappa}$ we have

$$\frac{(G'_\infty)^2}{\nu\eta(t)} + \frac{1}{\nu\delta(t)\eta(t)} + \frac{1}{\nu^2\eta(t)} = O\left(\frac{1}{\nu^{1-4\kappa}}\right) = o(1),$$

uniformly in $t > \nu^{-\kappa}$. We conclude from (2.26) that

$$(2.28) \quad \left((1 - G_\nu(t)^2) - \frac{\lambda_0(\nu)}{\lambda_2(\nu)} (G'_\nu)^2 \right)^{-1} = \left((1 - G_\infty^2) - \frac{\bar{\lambda}_0}{\bar{\lambda}_2} (G'_\infty)^2 \right)^{-1}$$

$$\times \left(1 + O\left(\frac{(G'_\infty)^2}{\nu\eta(t)} + \frac{1}{\nu\delta(t)\eta(t)} + \frac{1}{\nu^2\eta(t)} \right) \right).$$

Since $H_\nu = H_\infty + O(\nu^{-1})$ we deduce

$$-H_\nu(1 - G_\nu)^2 + \frac{\lambda_0(\nu)}{\lambda_2(\nu)} (G'_\nu)^2 G_\nu = -H_\infty(1 - G_\infty)^2 + \frac{\bar{\lambda}_0}{\bar{\lambda}_2} (G'_\infty)^2 G_\infty + O\left(\frac{1}{\nu}\right).$$

Recalling that

$$\rho_\nu = \frac{-H_\nu(1 - G_\nu^2) + \frac{\lambda_0(\nu)}{\lambda_2(\nu)} (G'_\nu)^2 G_\nu}{(1 - G_\nu^2) - \frac{\lambda_0(\nu)}{\lambda_2(\nu)} (G'_\nu)^2}$$

and $-H_\infty(1 - G_\infty)^2 + \frac{\bar{\lambda}_0}{\bar{\lambda}_2} (G'_\infty)^2 G_\infty = O(\delta^{-1})$ we see that (2.27) follows from (2.28). $\square$

Consider the function

$$A(u) = \sqrt{1 - u^2} + u \arcsin u, \quad |u| \leq 1.$$

Observe that

$$(2.29a) \quad \frac{dA}{du} = O(1), \quad \forall |u| \leq 1,$$

$$(2.29b) \quad \frac{dA}{du} = \arcsin u = O(u) \text{ as } u \rightarrow 0.$$

Now fix an exponent $\kappa \in (0, \frac{1}{4})$. We discuss separately two cases.

1. If $\nu^k < t < \pi\nu$. Then in this range we have

$$\frac{1}{\delta}, \quad \rho_\infty = O(t^{-1}), \quad \rho_\nu = \rho_\infty + o(1), \quad \frac{1}{\eta(t)} = O(1),$$

and using (2.29b) and (2.27) we deduce

$$(2.30) \quad \begin{aligned} A(\rho_\nu) &= A(\rho_\infty) + A'(\rho_\infty)(\rho_\nu - \rho_\infty) + O((\rho_\nu - \rho_\infty)^2) \\ &= A(\rho_\infty) + O\left(\frac{1}{t\nu} + \frac{1}{\nu^2}\right). \end{aligned}$$

2. $\nu^{-\kappa} < t < \nu^\kappa$. The equality (2.20) shows that in this range we have

$$\frac{1}{\eta(t)} = O(\nu^{-4\kappa}), \quad \frac{1}{\delta(t)} = O(1)$$

so that and (2.27) implies that

$$\rho_\nu - \rho_\infty = O\left(\frac{1}{\nu^{1-4k}}\right).$$

Using (2.29a) we deduce

$$(2.31) \quad A(\rho_\nu) - A(\rho_\infty) = O\left(\frac{1}{\nu^{1-4k}} + \frac{1}{\nu^{1-4\kappa}\delta(t)^2} + \frac{1}{\nu^{2-8\kappa}\delta(t)}\right).$$

Set

$$\Delta_\nu := \mathcal{C}_\nu A(\rho_\nu) - \mathcal{C}_\infty A(\rho_\infty), \quad q_\nu := \left(\frac{\lambda_2(\nu)}{\lambda_0(\nu)}\right), \quad q_\infty = \left(\frac{\bar{\lambda}_2}{\bar{\lambda}_0}\right).$$

Then using (2.25) we deduce that

$$q_\nu - q_\infty = \frac{6}{5}\nu^{-1} + O(\nu^{-2}), \quad q_\nu = q_\infty (1 + 2\nu^{-1} + O(\nu^{-2})).$$

Then

$$\left(f_\nu(t) - q_\nu\right) - \left(f_\infty(t) - q_\infty\right) =$$

$$\begin{aligned}
&= q_\nu (\mathcal{C}_\infty A_\infty(\rho_\infty) - 1 + \Delta_\nu) - q_\infty (\mathcal{C}_\infty A(\rho_\infty) - 1) \\
&= (q_\nu - q_\infty) (\mathcal{C}_\infty A(\rho_\infty) - 1) + q_\infty \Delta_\nu.
\end{aligned}$$

To prove (1.2) we need to prove the following equality.

$$\begin{aligned}
(2.32) \quad & (q_\nu - q_\infty) \int_0^{\pi\nu} (\mathcal{C}_\infty(t) A(\rho_\infty(t)) - 1) dt, \\
& q_\infty \int_0^{\pi\nu} \Delta_\nu(t) dt = o(1) \text{ as } \nu \rightarrow \infty.
\end{aligned}$$

We can dispense easily of the first integral above since $\mathcal{C}_\infty(t) A(\rho_\infty(t)) - 1$ is absolutely integrable on $[0, \infty)$ and $q_\nu - q_\infty = O(\nu^{-1})$.

The second integral requires a bit of work. More precisely, we will show the following result.

Lemma 2.10. *If $0 < \kappa < \frac{1}{5}$, then*

$$(2.33) \quad \int_0^{\nu^{-\kappa}} \Delta_\nu(t) dt, \quad \int_{\nu^{-\kappa}}^{\nu^\kappa} \Delta_\nu(t) dt, \quad \int_{\nu^\kappa}^{\pi\nu} \Delta_\nu(t) dt = o(1) \text{ as } \nu \rightarrow \infty.$$

Proof. We will discuss each of the three cases separately.

1. $0 < t < \nu^{-\kappa}$. The easiest way to prove that $\int_0^{\nu^{-\kappa}} \Delta_\nu(t) dt \rightarrow 0$ is to show that

$$\mathcal{C}_\nu(t) A(\rho_\nu(t)) = O(1), \quad 0 < t < \nu^{-\kappa}.$$

This follows using Lemma 2.7 and observing that the function $A(u)$ is bounded.

2. $\nu^{-\kappa} < t < \nu^\kappa$. In this range we have

$$\frac{1}{\eta} = O(\nu^{-4\kappa}), \quad \frac{1}{\gamma(t)} = O(\nu^{-2\kappa}), \quad \frac{1}{\delta(t)} = O(1), \quad G'_\infty(t) = O(1).$$

Using (2.22), (2.31) we deduce

$$\mathcal{C}_\nu(t) = \mathcal{C}_\infty(t) + O\left(\frac{1}{\nu^{1-3\kappa}}\right), \quad A(\rho_\nu) = A(\rho_\infty) + O\left(\frac{1}{\nu^{1-4\kappa}}\right).$$

Hence

$$\Delta_\nu = O\left(\frac{1}{\nu^{1-4\kappa}}\right) \quad \text{and} \quad \int_{\nu^{-\kappa}}^{\nu^\kappa} \Delta_\nu(t) dt = O\left(\frac{1}{\nu^{1-5\kappa}}\right) = o(1).$$

3. $\nu^\kappa < t < \pi\nu$. For these values of t we have

$$\eta(t), \frac{1}{\eta(t)} = O(1), \quad \frac{1}{\delta(t)} = O(t^{-1}).$$

Using (2.22) and (2.30) we deduce

$$\mathcal{C}_\nu(t) = \mathcal{C}_\infty(t) + O\left(\frac{1}{\nu t} + \frac{1}{\nu^2}\right), \quad A(\rho_\nu) = A(\rho_\infty) + O\left(\frac{1}{\nu t} + \frac{1}{\nu^2}\right)$$

so that

$$\Delta_\nu(t) = O\left(\frac{1}{\nu t} + \frac{1}{\nu^2}\right), \quad \int_{\nu^{-\kappa}}^{\pi\nu} \Delta_\nu(t) dt = O\left(\frac{1}{\nu} + \frac{\log \nu}{\nu}\right) = o(1).$$

□

The fact that δ_∞ defined as in (1.2) is positive follows by arguing exactly as in [4, §3.2]. This completes the proof of Theorem 1.1.

Remark 2.11. The proof of Lemma 2.10 shows that for any $\varepsilon > 0$ we have

$$(2.34) \quad \text{var}(Z_\nu) = \nu\delta_\infty + O(\nu^\varepsilon) \quad \text{as } \nu \rightarrow \infty.$$

Numerical experiments suggest that $\delta_\infty \approx 0.35$.

□

A. Some elementary estimates

Proof of Lemma 2.1. Consider the complex valued random process

$$\mathcal{F}_\nu(t) := \frac{1}{\sqrt{\pi\nu^3}} \sum_{m=1}^{\nu} m z_m e^{\frac{imt}{\nu}}, \quad z_m = c_m - id_m.$$

The covariance function of this process is

$$\mathcal{R}_\nu(t) = \mathbf{E}(\mathcal{F}_\nu(t)\overline{\mathcal{F}_\nu(0)}) = \frac{1}{\pi\nu^3} \sum_{m=1}^{\nu} m^2 e^{\frac{imt}{\nu}}.$$

Observe that $\mathbf{Re} \mathcal{F}_\nu = \Phi_\nu$. Note that the spectral measure of the process $\mathcal{F}_\nu$ is

$$d\sigma_\nu = \frac{1}{\pi\nu^3} \sum_{m=1}^{\nu} m^2 \delta_{\frac{m}{\nu}},$$

where δ_{t_0} denotes the Dirac measure on $\mathbb{R}$ concentrated at t_0 . We form the covariance matrix of the Gaussian vector valued random variable

$$\begin{bmatrix} \mathcal{F}_\nu(0) \\ \mathcal{F}_\nu(t) \\ \mathcal{F}'_\nu(0) \\ \mathcal{F}'_\nu(t) \end{bmatrix} \rightarrow \mathcal{X}_\nu(t) = \begin{bmatrix} \mathcal{R}_\nu(0) & \overline{\mathcal{R}}_\nu(t) & \overline{\mathcal{R}}'_\nu(0) & \overline{\mathcal{R}}'_\nu(t) \\ \mathcal{R}_\nu(t) & \mathcal{R}_\nu(0) & -i\mathcal{R}'_\nu(t) & -i\overline{\mathcal{R}}'_\nu(0) \\ \mathcal{R}'_\nu(0) & i\overline{\mathcal{R}}'_\nu(t) & -\mathcal{R}''_\nu(0) & -\overline{\mathcal{R}}''_\nu(t) \\ \mathcal{R}'_\nu(t) & i\mathcal{R}'_\nu(0) & -\mathcal{R}''_\nu(t) & -\overline{\mathcal{R}}''_\nu(0) \end{bmatrix}.$$

Observe that $\mathbf{Re} \mathcal{X}(t) = \mathbf{Re} \Xi(t)$. If we let

$$\vec{z} = \begin{bmatrix} u_0 \\ v_0 \\ u_1 \\ v_1 \end{bmatrix} \in \mathbb{C}^4.$$

Then, as in [2, Eq. (10.6.1)] we have

$$\langle \mathcal{X}_\nu \vec{z}, \vec{z} \rangle = \frac{1}{\pi \nu^3} \sum_{m=1}^{\nu} m^2 \left| \left(u_0 + v_0 e^{\frac{imt}{\nu}} \right) + \frac{im}{\nu} \left(u_1 + v_1 e^{\frac{imt}{\nu}} \right) \right|^2.$$

Hence

$$(A.1) \quad \langle \mathcal{X}_\nu \vec{z}, \vec{z} \rangle = 0 \Leftrightarrow \left(u_0 + v_0 e^{\frac{imt}{\nu}} \right) + \frac{im}{\nu} \left(u_1 + v_1 e^{\frac{imt}{\nu}} \right) = 0, \forall m = 1, \dots, \nu.$$

We see that if the linear system (A.1) has a nontrivial solution $\vec{z}$, then the complex 4×4 matrix

$$A_\nu(t) := \begin{bmatrix} 1 & \zeta & 1 & \zeta \\ 1 & \zeta^2 & 2 & 2\zeta^2 \\ 1 & \zeta^3 & 3 & 3\zeta^3 \\ 1 & \zeta^4 & 4 & 4\zeta^4 \end{bmatrix}, \quad \zeta = e^{\frac{it}{\nu}},$$

must be singular, i.e., $\det A_\nu(t) = 0$. We have

$$\det A_\nu(t) = \det \begin{bmatrix} 1 & \zeta & 1 & \zeta \\ 0 & \zeta^2 - \zeta & 1 & 2\zeta^2 - \zeta \\ 0 & \zeta^3 - \zeta & 2 & 3\zeta^3 - \zeta \\ 0 & \zeta^4 - \zeta & 3 & 4\zeta^4 - \zeta \end{bmatrix} = \zeta^2 \det \begin{bmatrix} 1 & 1 & 1 & 1 \\ 0 & \zeta - 1 & 1 & 2\zeta - 1 \\ 0 & \zeta^2 - 1 & 2 & 3\zeta^2 - 1 \\ 0 & \zeta^3 - 1 & 3 & 4\zeta^3 - 1 \end{bmatrix}$$

$$\begin{aligned}
&= \zeta^2 \det \begin{bmatrix} \zeta - 1 & 1 & 2\zeta - 1 \\ \zeta^2 - 1 & 2 & 3\zeta^2 - 1 \\ \zeta^3 - 1 & 3 & 4\zeta^3 - 1 \end{bmatrix} = \zeta^2 \det \begin{bmatrix} \zeta - 1 & 1 & \zeta \\ \zeta^2 - 1 & 2 & 2\zeta^2 \\ \zeta^3 - 1 & 3 & 3\zeta^3 \end{bmatrix} \\
&= \zeta^3 \det \begin{bmatrix} \zeta - 1 & 1 & 1 \\ \zeta^2 - 1 & 2 & 2\zeta \\ \zeta^3 - 1 & 3 & 3\zeta^2 \end{bmatrix} = \zeta \det \begin{bmatrix} \zeta - 1 & 1 & 0 \\ \zeta^2 - 1 & 2 & 2\zeta^2 - 2 \\ \zeta^3 - 1 & 3 & 3\zeta^3 - 3 \end{bmatrix} \\
&= \zeta^3 \det \begin{bmatrix} \zeta - 1 & 1 & 0 \\ \zeta^2 - 2\zeta + 1 & 0 & 2\zeta^2 - 2 \\ \zeta^3 - 3\zeta + 2 & 0 & 3\zeta^3 - 3 \end{bmatrix} \\
&= \zeta^3 \det \begin{bmatrix} \zeta - 1 & 1 & 0 \\ (\zeta - 1)^2 & 0 & 2(\zeta - 1)(\zeta + 1) \\ \zeta^3 - 3\zeta + 2 & 0 & 3\zeta^3 - 3 \end{bmatrix} \\
&= \zeta^3(\zeta - 1) \det \begin{bmatrix} \zeta - 1 & 1 & 0 \\ (\zeta - 1) & 0 & 2(\zeta + 1) \\ (\zeta - 1)^2(\zeta + 1) & 0 & 3(\zeta - 1)(\zeta^2 + \zeta + 1) \end{bmatrix} \\
&= \zeta^3(\zeta - 1)^3 \det \begin{bmatrix} 1 & 1 & 0 \\ 1 & 0 & 2(\zeta + 1) \\ \zeta + 1 & 0 & 3(\zeta^2 + \zeta + 1) \end{bmatrix} \\
&= -\zeta^3(\zeta - 1)^3 (3(\zeta^2 + \zeta + 1) - 2(\zeta^2 + 2\zeta + 1)) \\
&= -\zeta^3(\zeta - 1)^3(\zeta^2 - \zeta - 1).
\end{aligned}$$

Since $|\zeta| = 1$, we that $\det A_\nu(t) = 0$ if and only if $t \in 2\pi\nu\mathbb{Z}$. $\square$

Proof of Lemma 2.5. Recall that $\theta := \frac{t}{2\nu}$, $f(\theta) := \frac{\sin \theta}{\theta}$. By (2.9) we have

$$\begin{aligned}
&\frac{t^{r+1}}{i^r \nu^{r+1}} D_{\nu,r}(t) \\
&= r! \left(\frac{2 \sin \left(\frac{(\nu+1)t}{2\nu} \right)}{f(\theta)^{r+1}} \cdot e^{\frac{i(\nu+r)t}{2\nu}} - e^{it} \sum_{j=1}^r i^{1-j} \frac{\binom{\nu+1}{j}}{\nu^j} t^j \cdot \left(\frac{e^{i\theta}}{f(\theta)} \right)^{r+1-j} \right).
\end{aligned}$$

Using (2.12) we deduce that

$$\left| \frac{t^{r+1}}{i^r \nu^{r+1}} D_{\nu,r}(t) - \frac{1}{i^r} I_r(t) \right| \leq 2r! t^{r+1} \left| \frac{\sin \left(\frac{(\nu+1)t}{2\nu} \right)}{f(\theta)^{r+1}} e^{ir\theta} - \sin \left(\frac{t}{2} \right) \right|$$

$$(A.2) \quad + r! \sum_{j=1}^r t^j \left| \frac{\binom{\nu+1}{j}}{\nu^j} \left(\frac{e^{i\theta}}{f(\theta)} \right)^{r+1-j} - \frac{1}{j!} \right|.$$

In the sequel we will use Landau's symbol O . The various implied constants will be independent of ν . Throughout we assume $0 < t \leq \pi\nu$. For $0 < \theta < \frac{\pi}{2}$ and $0 \leq j \leq r$ we have

$$e^{i\theta} = 1 + O(\theta), \quad \frac{\binom{\nu+1}{j}}{\nu^j} = 1 + O\left(\frac{1}{\nu}\right), \quad \sin\left(\frac{(\nu+1)t}{2\nu}\right) = \sin\left(\frac{t}{2}\right) + O(\theta),$$

$$\frac{e^{i\theta}}{f(\theta)} = \frac{\theta(\cos \theta + i \sin \theta)}{\sin \theta} = 1 + O(\theta).$$

Hence

$$(A.3) \quad \left| \frac{\sin\left(\frac{(\nu+1)t}{2\nu}\right)}{f(\theta)^{r+1}} e^{ir\theta} - \sin\left(\frac{t}{2}\right) \right| = O(\theta),$$

while for any $1 \leq j \leq r$ we have

$$(A.4) \quad \left| \frac{\binom{\nu+1}{j}}{\nu^j} \left(\frac{e^{i\theta}}{f(\theta)} \right)^{r+1-j} - \frac{1}{j!} \right| = O\left(\frac{1}{\nu} + \theta\right).$$

Using (A.3) and (A.4) in (A.2) we deduce that

$$\left| \frac{t^{r+1}}{i^r \nu^{r+1}} D_{\nu,r}(t) - \frac{1}{i^r} I_r(t) \right| = O\left(\theta + \left(\theta + \frac{1}{\nu}\right) \sum_{j=1}^{r-1} t^j\right) = O\left(\frac{1}{\nu} \sum_{j=1}^{r+1} t^j\right).$$

Hence

$$\left| \frac{1}{i^r \nu^{r+1}} D_{\nu,r}(t) - \frac{1}{i^r t^{r+1}} I_r(t) \right| = O\left(\frac{1}{\nu t^r} \frac{(1-t^{r+1})}{(1-t)}\right).$$

□

Proof of Lemma 2.6. We have

$$R_{\infty}^{(k)}(t) = \pm \frac{1}{t^{k+3}} \int_0^t \tau^{k+2} u(\tau) d\tau, \quad u(\tau) = \begin{cases} \sin \tau, & k \in 1 + 2\mathbb{Z} \\ \cos \tau, & k \in 2\mathbb{Z} \end{cases}.$$

Note that

$$|R_{\infty}^{(k)}(0)| = \frac{1}{k+3} = \frac{1}{t^{k+3}} \int_0^t \tau^{k+2} d\tau.$$

The inequality (2.18a) now follows from the inequality $|u(\tau)| \leq 1, \forall \tau$.

For any positive integer r we denote by $\mathbf{j}_r$ the r -th jet at 0 of a one-variable function. We can rewrite (2.12) as follows:

$$\begin{aligned} \frac{1}{i^r} I_r(t) &= r! \left(2 \sin\left(\frac{t}{2}\right) e^{\frac{it}{2}} - i e^{it} \sum_{j=1}^r \frac{(-it)^j}{j!} \right) \\ &= r! \left(2 \sin\left(\frac{t}{2}\right) e^{\frac{it}{2}} - i e^{it} \cdot \mathbf{j}_r(e^{-it} - 1) \right) \\ &= r! \left(2 \sin\left(\frac{t}{2}\right) e^{\frac{it}{2}} + i e^{it} - i e^{it} \cdot \mathbf{j}_r(e^{-it}) \right) \\ &= r! \left(-i(e^{\frac{it}{2}} - e^{-\frac{it}{2}}) e^{\frac{it}{2}} + i e^{it} - i e^{it} \cdot \mathbf{j}_r(e^{-it}) \right) \\ &= i r! \left(1 - e^{it} \cdot \mathbf{j}_r(e^{-it}) \right). \end{aligned}$$

Hence $\mathbf{Re} \left(\frac{1}{i^r} I_r(t) \right) = \mathbf{Im} \left(e^{it} \cdot \mathbf{j}_r(e^{-it}) \right)$ and $\frac{1}{t^{r+1}} I_r(t) = O(t^{-1})$ $t \rightarrow \infty$. This proves (2.18b).

The spectral measure $d\sigma_{\nu} = \frac{1}{\pi\nu^3} \sum_{m=1}^{\nu} m^2 \delta_{\frac{m}{\nu}}$ of the process $\mathcal{F}_{\nu}$ converges weakly as $\nu \rightarrow \infty$ to the measure $d\sigma_{\infty} = \frac{1}{\pi} \chi_{[0,1]} t^2 dt$, where $\chi_{[0,1]}$ denotes the characteristic function of $[0, 1]$. Indeed, an argument identical to the one used in the proof of Lemma 2.3 shows that for every continuous bounded function $f : \mathbb{R} \rightarrow \mathbb{R}$ we have

$$\lim_{\nu \rightarrow \infty} \int_{\mathbb{R}} f(t) d\sigma_{\nu}(t) = \int_{\mathbb{R}} f(t) d\sigma_{\infty}.$$

The complex valued stationary Gaussian process $\mathcal{F}_{\infty}$ on $\mathbb{R}$ with spectral measure $d\sigma_{\infty}$ has covariance function $\mathcal{R}_{\infty} = \frac{1}{\pi} \int_0^1 t^2 e^{it} dt$. Note that $\mathbf{Re} \mathcal{R}_{\infty} = R_{\infty}$. The results in [2, §10.6] show that the covariance matrix

$$\mathcal{X}_{\infty} = \begin{bmatrix} \mathcal{R}_{\infty}(0) & \overline{\mathcal{R}}_{\infty}(t) & \overline{\mathcal{R}}'_{\infty}(0) & \overline{\mathcal{R}}'_{\infty}(t) \\ \mathcal{R}_{\infty}(t) & \mathcal{R}_{\infty}(0) & -i\mathcal{R}'_{\infty}(t) & -i\overline{\mathcal{R}}'_{\infty}(0) \\ \mathcal{R}'_{\infty}(0) & i\overline{\mathcal{R}}'_{\infty}(t) & -\mathcal{R}''_{\infty}(0) & -\overline{\mathcal{R}}''_{\infty}(t) \\ \mathcal{R}'_{\infty}(t) & i\overline{\mathcal{R}}'_{\infty}(0) & -\mathcal{R}''_{\infty}(t) & -\overline{\mathcal{R}}''_{\infty}(0) \end{bmatrix} = \lim_{\nu \rightarrow \infty} \mathcal{X}_{\nu},$$

is nondegenerate. The equality $\det \mathbf{Re} \mathcal{X}_\infty(t) \neq 0$, $\forall t \in \mathbb{R}$ implies as in Remark 2.2 that $\mu_\infty(t) \neq 0$, $|\rho_\infty(t)| < 1$, $\forall t \in \mathbb{R}$, where

$$\mu_\infty = \frac{(\bar{\lambda}_0^2 - R_\infty^2)\bar{\lambda}_2 - \bar{\lambda}_0(R'_\infty)^2}{\lambda_0^2 - R_\infty^2}, \quad \rho_\infty = \frac{R''_\infty(\bar{\lambda}_0^2 - R_\infty^2) + (R'_\infty)^2 R_\infty}{(\bar{\lambda}_0^2 - R_\infty^2)\bar{\lambda}_2 - \bar{\lambda}_0(R'_\infty)^2}.$$

This proves (2.18c). The equality (2.18d) follows from the Taylor expansion of R_∞ . $\square$
