- The amount we pay depends on the amount of time our car stays in the lot so cost $(\mathrm{C})$ is a function of time $(\mathrm{t})$.

\$ 6 & 2 \mathrm{hr} .<t \leq 3 \mathrm{hr} . \\
\$ 8 & 3 \mathrm{hr} .<t \leq 4 \mathrm{hr} \\
\$ 10 & 4 \mathrm{hr} .<t \leq 5 \mathrm{hr} . \\
\$ 12 & 5 \mathrm{hr} .<t \leq 6 \mathrm{hr} \\
\$ 13 & 6 \mathrm{hr} .<t \leq 24 \mathrm{hr} . \\

-(x-1) & (x-1) \leq 0 \\
(x-1) & (x-1)>0
\end{array}\right.
$$

- Replacing $x$ by $(x-1)$ in the definition of the absolute value function above, we get

$$
h(x)=|x-1|=\left\{\begin{array}{cl}
-(x-1) & (x-1) \leq 0 \\
(x-1) & (x-1)>0
\end{array}\right.
$$

- Working through the details, we get

$$
h(x)=|x-1|=\left\{\begin{array}{cc}
1-x & x \leq 1 \\
(x-1) & x>1
\end{array}\right.
$$

## Graphs on the Cartesian Plane.

(Please review, graphing and functions in your online homework.) When we give a formula, for a function of $x, f(x)$, we can associate an equation to the function $y=f(x)$. $x$ is a variable, called the independent variable.
$y$ is called a dependent variable.
The graph of a function $f$, with associated formula $f(x)$, is the set of all points $(x, y)$ on the $x y$-plane that satisfy the equation $y=f(x)$. This is just a picture of all points of the form $(x, f(x))$ on the plane.
The domain of a function can be identified from the graph as the set of all values of $x$ for which a vertical line through $x$ cuts the graph (the values of $x$ on the graph).
The range of a function can be identified from the graph as the set of all values of $y$ for which a horizontal line through $y$ cuts through the graph (the values of $y$ on the graph).
You should already be very familiar with the graphs shown in the catalogue at the end of the lecture.

$$

## Graphing general equations

Graphing general equations: We can plot the points on any curve defined by an equation in $x$ and $y$ on the $x y$-plane. However, we cannot always solve for $y$ uniquely in such equations and the graph may not be the graph of a function of the form $y=f(x)$.

Example the graph of the equation of a circle of radius 5 with center at $(0,0)$ is shown on the left below:

- Clearly the graph of the equation $x^{2}+y^{2}=25$ does not pass the vertical line test (see the vertical line drawn in the picture on the right below)
- On the other hand the upper half of the above circle does pass the VLT and is the graph of the function, $f(x)=\sqrt{25-x^{2}}$.

VERTICAL AND HORIZONTAL SHIFTS Suppose $c>0$. To obtain the graph of
$y=f(x)+c$, shift the graph of $y=f(x)$ a distance $c$ units upward
$y=f(x)-c$, shift the graph of $y=f(x)$ a distance $c$ units downward
$y=f(x-c)$, shift the graph of $y=f(x)$ a distance $c$ units to the right
$y=f(x+c)$, shift the graph of $y=f(x)$ a distance $c$ units to the left

Example Sketch the graph of the equation $y=x^{2}-6 x+14$.

- $y=x^{2}-6 x+14=\left[x^{2}-6 x+\left(\frac{-6}{2}\right)^{2}\right]-\left(\frac{-6}{2}\right)^{2}+14$
- $=[x-6 x+9]+5=(x-3)^{2}+5$
- To graph this equation, we shift the graph of $y=x^{2}$, first by three units to the right and then five units upwards.
$y=(x-3)^{2}+5$



## Stretching, Compressing and Reflecting Graphs

## VERTICAL AND HORIZONTAL STRETCHING AND REFLECTING Suppose $c>1$. To

 obtain the graph of$$
\begin{aligned}
& y=c f(x), \text { stretch the graph of } y=f(x) \text { vertically by a factor of } c \\
& y=(1 / c) f(x), \text { compress the graph of } y=f(x) \text { vertically by a factor of } c \\
& y=f(c x) \text {, compress the graph of } y=f(x) \text { horizontally by a factor of } c \\
& y=f(x / c) \text {, stretch the graph of } y=f(x) \text { horizontally by a factor of } c \\
& y=-f(x) \text {, reflect the graph of } y=f(x) \text { about the } x \text {-axis } \\
& y=f(-x), \text { reflect the graph of } y=f(x) \text { about the } y \text {-axis }
\end{aligned}
$$

In the Appendix, it is demonstrated how to use these techniques to graph $y=2 \sin (4 x)$.

## Operations on Functions

As well as being able to add, subtract, multiply and divide functions, we can form the composition of two functions $f$ and $g$.
Definition Given two functions $f$ and $g$, the composite function $f \circ g$ is defined by

$$
(f \circ g)(x)=f(g(x))
$$

The domain of $f \circ g$ is the set of all $x$ such that

1. $x$ is in the domain of $g$ and
2. $g(x)$ is in the domain of $f$

It is implicit in the definition of the function, that we first calculate $g(x)$ and then apply $f$ to the result. Hence any $x$ in the domain must satisfy the above two conditions.
(When calculating the domain, calculating just the formula for $f \circ g$ or $g \circ f$ can be misleading)
