George Anastaplo is Professor of Law, Loyola University of Chicago; Lecturer in the Liberal Arts, The University of Chicago; and Professor Emeritus of Political Science and of Philosophy, Dominican University. His most recent books are *The Thinker as Artist: from Homer to Plato and Aristotle, Abraham Lincoln: A Constitutional Biography* and *But Not Philosophy: Seven Introductions to Non-Western Thought.*

James Arraj is the co-director of Inner Explorations, an extensive website (www.innerexplorations.com) where Christian mysticism and metaphysics meet Jungian psychology, Eastern religions and a new sense of the earth. He is the author of a dozen books including *Mysticism*, *Metaphysics and Maritain*, *The Mystery of Matter* and *From St. John of the Cross to Us*.

Fr. Joseph M. de Torre, of the Opus Dei prelature, is the University Professor of Social and Political Philosophy at the University of Asia and the Pacific in Manila. He has published more than twenty books and hundreds of articles and essays.

Robert A. Delfino is Assistant Professor of Philosophy at St. John's University. He received his Ph.D. from State University of New York at Buffalo. His primary interests are in metaphysics and ethics, with special attention to Aquinas and Aristotle. He has recently published "Aristotle on the Value of the History of Philosophy for Philosophy." He maintains the official webpage of the American Maritain Association.

Raymond Dennehy is Professor of Philosophy at the University of San Francisco, where he teaches metaphysics, epistemology, bioethics and political philosophy. He is a former president of the American Maritain Association, editor of the anthology, *Christian Married Love* and author of *Reason and Dignity* and the forthcoming book, *Anti-Abortionist at Large*. He has also published many scholarly articles and is a frequently invited guest on television, radio, and university campuses to discuss contemporary ethical issues.

John M. Dunaway is professor of French and Interdisciplinary Studies at Mercer University in Macon, Georgia. His published writings have centered on French religious writers, especially Maritain, Julien Green, and Simone Weil. He has served on the Executive Board and as Vice-President of the American Maritain Association.

Robert Fallon is currently completing his doctoral dissertation in the musicology program at the University of California, Berkeley. An editor of *Repercussions: Critical and Alternative Viewpoints on Music and Scholarship*, he has written on twentieth-century musical cultures in France, England, Germany and the United States.

Desmond FitzGerald is Professor Emeritus of Philosophy, University of San Francisco. Born in Toronto, he studied at St. Michael's College, University of Toronto, where he attended the lectures of Jacques Maritain in 1942 and 1943. He received his M.A. in Philosophy from the Pontifical Institute of Mediaeval Studies, studying under Étienne Gilson and Anton C. Pegis.
